- 2. The quotations received after this deadline shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
- 3. Unsealed quotation will be rejected.
- 4. Quotations must be in the enclosed prescribed Proforma and forwarding letter on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative, in case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation.
- 5. Rates must be quoted as per the format specified taxes extra if any must be written separately. The rates must be quoted in figures as well as in words.
- 6. In general no overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected. However, except rate all cuttings and over writings must be signed by the authorized person of the firm.

4. RELEASE OF PURCHASE ORDER

- 1. It is not binding on the part of the Director, NCDIR, Bengaluru to accept the lowest or any other quotation and the Director reserves the right to reject or accept any quotation fully or partly. The Director, NCDIR, Bengaluru reserves the right to accept and place the supply orders to the successful agency.
- 2. The Director, NCDIR, Bengaluru also reserves the right to relax or waive any of the conditions and reject the quotation if any one of the conditions enumerated above, is violated or the quotation gives any counter condition.

5. TECHNICAL REQUIREMENTS FOR EPABX

- 1. The EPABX should be fully digital and should employ Stored Program Control (SPC) using Pulse Code Modulation (PCM) confirming to latest ITUT Standards.
- 2. The system should support not only Internet Protocol (IP) but also Time Division Multiplexers (TDM) and Session Initiation Protocol (SIP) network.
- 3. EPABX should be of reputed make.
- 4. The system shall be 100% non-blocking.
- 5. The system shall utilize single codec per line.
- 6. Extension could be Digital phone, and analog phone.
- 7. It should be possible to remove and put back line or trunk card from the system even in online condition, hot plugin / hot swapping feature.
- 8. The EPABX with Transmission Control Protocol-Internet Protocol (TCP-IP) connectivity (10/100 Base T on RJ 45) should also support Remote Local Area Network (LAN) Access apart from the support for voice communication. There should be fire-wall concept checking both the Source IP Address
- 9. The EPABX should have integrated Universal Call Distribution system (UCD) in-built to support with.
- 10. It should be possible to network with exchanges of different makes/ technologies using either earth & magneto, or ear & mouth (E&M) lines or Integrated Services Digital Network (ISDN), Primary Rate Interface (PRI) lines and Global System for Mobile communications (GSM) line as fall back..
- 11. The exchange shall accept different type of trunk signalling such as:
 - EDSS1/1TR6 for ISDN BRI/PRI
 - Ring down.
 - 2W/4W E&M signalling, Type 1 to Type 5
 - Analog C.O. Lines

- 12. The exchange should be suited to work on AC mains supply of 230 V AC supply.
- 13. The system should have emergency transfer facility to automatically route the C.O. lines to predefined extensions in case of power failure.
- 14. The system shall support PRI ISDN in 30 bearer channels and one data (30B+D) Format.
- 15. The system should support voice processing applications such as Voice Mail, Auto attendant.
- 16. The EPABX should be suitable up to 3/4 digit extension numbering scheme. This Numbering scheme should be flexible. System should also allow mixed numbering scheme.

- 18. In night mode when the operator is not present at the console, the direct lines will have to be routed to different extensions for incoming calls. Once the call lands in the department it should be possible to answer it from any station.
- 19. It should also be possible to have a different class of service during the day and during the night.
- 20. The system should have automatic root selection facility to determine least cost root automatically based on class of service.
- 21. Service access mode with emergency stand alone operation
- 22. The system should be able to restart automatically without human intervention when the external AC power supply is resumed after complete power failure.
- 23. The system should have integrated Modem on the central motherboard for remote maintenance.
- 24. There should be an LED indication on each card, which can help determine the state of the card.
- 25. The system software should be protected against loss/ alteration of memory due to power failure, unauthorized command or any other fault condition.
- 26. System should be supplied with suitable call billing software.

b. Main Distribution Frame (MDF)

A Krone MDF mounted in sheet steel enclosure shall be supplied along with the Exchange. Integrated Protection Module (IPM) shall be provided in the MDF for all junction lines and external one. All cables coming from field will be terminated on the MDF.

c. Protection:

All circuits such as individual subscribers, CPU memory etc. shall be protected with current limiting devices or Semi-Conducting fuses. Trusted Platform Module (TPM) shall be provided for subscriber lines.

The **EPABX** shall be installed in the Telephone Exchange Room. The EPABX capacity shall be as mentioned in schedule with suitable motherboard for expansion as per schedule of quantities.

7. INSTALLATION AND COMMISSIONING

Installation and commissioning covers followings:

- a. Exchange equipment mounting and turn on
- b. Office data programming
- c. Functional testing
- d. One day operator training
- e. Site preparation including carpentry, civil and masonry work etc.
- f. Cable identification and termination on existing / new boxes
- g. Field cabling termination on MDF

8. WARRANTY

The equipment offered is guaranteed against manufacturing defects for a period of minimum 3 years from the date of commissioning. After that should provide 2 years of extended comprehensive AMC contract. This should be quoted separately in offer.

During this period, the parts going defective shall be replaced or repaired free of cost. The warranty of the replaced / repaired parts shall not exceed the warranty period of the main equipment.
