Terms and conditions

- 1. The rates should be quoted for finishing size 7.25"X9.5".
- 2. Perfect matching for colour shades between pages should be ensured.
- 3. Proof of text, graphs and tables including colour proofs should be provided for verification before printing.
- 4. Approximate estimated pages 186 plus or minus 10 pages.
- 5. Specific rate with reference to extra pages if any should be quoted. Such pro-rate is also applicable for lesser pages if any than estimated pages.
- 6. Rates should be quoted only for printing. The rate should not include DTP charges.
- 7. The persons responding to quotation should have modern facility for four colour printing such as direct computer to plate transfer machine etc.
- 8. The books should bounded with stitching and perfect binding.
- 9. No extra charge will be paid for the proof.
- 10. Each book has to have shrink packing (clinging transparent cover) and packed in individual card board package (25 books per box).
- 11. The sample of the papers to be used for printing in accordance with the prescribed specification should accompany the quotation duly signed on behalf of the firm with detailed specification i.e. Name of the paper, GSM and ream weight etc.
- 12. Printer is required to submit a proof copy of the material along with cover design (in 3 days) to the undersigned for necessary scrutiny and approval

- 13. The quotation should be valid at least for a period of one year from the date of closing of quotation.
- 14. **Validity:** The rates to be quoted are valid for minimum period of one year and any further orders during the period holds good for repeat orders. The rates once quoted should not be altered for any reasons during the period.
- 15. Time limit: Within one week from the date of issue of work / purchase order for printing.
- 16. Taxes: Government taxes as applicable should be clearly mentioned in your quotations.
- 17. The printing work will be entrusted to the lowest tenderer.
