2. You are requested to submit the following documents in original for verification at the time of document verification. If you fail to bring the original documents, you will not be permitted to attend the written test.
  - All testimonials / Certificate in original copies related to education, experience and registration. One set of self-attested copies may kindly be submitted during the document verification.
  - Caste certificate (if applicable) in original should be produced at the time of verification of original documents.
  - No objection certificate from the present employer if your application was not forwarded through proper channel failing which you will not be allowed to appear in the written test / personal discussion / interview.
3. A photocopy of your photo identity card should be submitted on the day of document verification / written test / personal discussion / interview.
4. One recent passport size photograph to be pasted on the admit card, and the admit card should be brought with you.
5. You are requested to produce the admit card during document verification / written test / personal discussion / interview.

If no confirmation is received, it will be assumed that you are not interested and will not be attending the document verification / written test.
2. Call for the document verification / written test does not in any way guarantee selection.
3. Successful candidates results will be published in the institutes website ([www.ncdirindia.org](http://www.ncdirindia.org)) No enquiry in this regard will be entertained.
4. You are further advised to bring 'No Objection Certificate' from your present employer, if you have taken any other employment after applying for the post at NCDIR, Bengaluru.
5. No Request for change in date of examination and centre will be considered under any circumstances.
6. The candidate is also required to bring one of the photo identification card in original viz. Voter Identity, Driving Licence, PAN card, Unique ID Card /Aadhar Card or passport along with this admit card. The identity of the candidate will be matched from the proof. In case the photograph is missing in your admit card, please bring two recent passport size photograph in the examination centre.
7. No candidate will be allowed to enter for the document verification / written test after the scheduled time of commencement of document verification / written test.
8. Possession and use of electronic devices such as mobile phone, micro phone or any other associated Accessories. Calculator, Log tables, Pager, Digital Diary Book / Notes etc. are strictly prohibited in the examination hall. If any candidate is found in possession of any of these devices / documents, his/her candidature is liable to be cancelled.
