Bidders are bound to accept the orders accordingly.

#### 2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceed ings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of bu yer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior w ritten consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severallyliable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

6. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of Director, ICMR-NCDIR, payable at Bangalore. After award of contract, Successful Bidder can upload scanned copy of the DD in place

of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of c ontract.

- 1.The Vendor should be registered in the City of Consignee i.e. Bangalore and Form C/Establishment certificate should be produced as documentary proof. Vehicle should be of Taxi type (commercial). No private vehicle is allowed.
- 2. The Vehicle should be parked in ICMR-NCDIR and Kms will be counted from ICMR-NCDIR Office to Office.
- 3. The Rates are inclusive of all taxes etc.
- 4. Parking and Toll charges will be paid extra on production of receipts.
- 5. Car will be used for Airport pickup & drop, Bank, Post Office (Packages) and other official purposes etc.
- 6. No night charges will be paid for night duties.
- 7. The drivers of the vehicles must possess a valid commercial driver license and must have a minimum 5y ears of driving experience.
- 8. No. of Vehicle required: 1 No. of Honda Amaze, Maruti Suzuki Dzire, Toyota Etios. The usage variant shal I be 2000 km and 320 hours per month.
- 9. The contract will initially be valid for one year. Based on the satisfactory performance of the firm, the contract may be extended for further period of two years, in the same rates and subject to satisfactory performance.
- 11. The rate of each vehicle should be quoted for 2000 km and 320 hours per month. No daily limit.
- 12. Vehicle will be hired on 24 X 7 basis.
- 13. Fuel of vehicle will be Petrol/ CNG/ Electrical.
- 14. No additional charges will be paid for Air Conditioner.
- 15. The Driver need to come in uniform.
- 16. The driver in no case shall report to duty in an inebriated state or consume alcohol while on duty. In su ch an event user department shall have full rights to terminate the contract with immediate effect.
- 17. Driver must be provided a working mobile phone and contact number be provided to user department

- 18. GST Registration Certificate and PAN copies should be uploaded.
- 19. PAYMENT TERMS
- 19.1 Payment Condition: (a) The cost of services quoted by the Service Provider shall be cover all aspects

of service delivery and include all the components of Fuel, salary/ wages (minimum wage, insurance, PF, E

- SI, etc) Service charges, GST etc., as applicable. (b) The Payment shall be made as per the financial quotes submitted by the Service Provider and accepted by the Buyer.
- 19.2 Payment Process: (a) Payment shall be made only after Submission of bill in duplicate along with duty slip and log book, non-submission of the same may lead to delay/ deduction in payment.
- (b) All the penalties/ fine/ interest (if applicable) shall be settled before making the payments. Service Provider shall not have any objection on the same.
- (c) Payment shall be made through bank transfer only, in no circumstance cash/ cheque payment shall be made.
- 19.3 The payment will be made directly by the ICMR-NCDIR.
- 20. In case two or more than two agencies quote the price, L-1 will be decided on experience of the agency
- i.e. the agency which has maximum years of experience shall be considered as L-1 in circumstances.
- 21. In case two or more agencies quote the price and having same years of experience the L-1 will be decided on turnover of the agency in the field of providing relevant services in last three financial years. H

ence, bidder is requested to submit the overall along with the turnover in the field of providing relevant ser vices in last three financial years.

- 22. In case of any breakdown of the vehicle, the owner has to arrange a substitute vehicle within one hour. Similarly, in the event of non-availability of driver due to sickness or any reason substitute driver will be provided for the vehicle immediately otherwise penalty will be levied. In the event of not providing vehicle, a similar vehicle may be hired from the market and expenditure for the same shall be deducted from the payable amount to vendor.
- 23. Decision taken by the Director, ICMR-NCDIR, Bengaluru at any point of time relating to this process of t ender shall be final and conclusive.
- 24. Conditions mentioned in the Additional Qualification/ Data Required shall prevail over Bid Details.
- 25. Terms and conditions acceptance letter should be submitted.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
